



Addendum to Touchsuite Merchant Processing Agreement

This shall serve as an Addendum to the Terms of Service (the "Addendum") of the Merchant Processing Agreement (MPA) between the Merchant and Touchsuite.

Merchant has represented to TouchSuite that they intend solely to offer hemp derived products to the general public and shall not use the card processing services or card processing account provided by TouchSuite for the purchase, payment, sale, exchange, delivery or refund of any products which are not fully excludable from the definition of marijuana utilized within the Controlled Substances Act as administered by the United States Department of Justice, Drug Enforcement Administration. Merchant shall not use the card processing services or card processing account for the purchase, payment, sale, exchange, delivery, or refund of any products containing marijuana based cannabidiol, cannabinoid, tetrahydrocannabinol (THC) in excess of 0.3 percent by dry weight or properly included under the Drug Enforcement Agency Drug Code 7350 or 7360. Merchant shall not offer any unapproved hemp derived products which have not been deemed approved for sale under all applicable local, state, or federal regulations governing or regulating the hemp derived products offered by the Merchant. Merchant shall not offer any unapproved hemp derived products which have not been deemed approved for sale by Touchsuite UW and Risk Policies including the following THC/CBD derivatives such as CBN (above 3% dry weight) THC-O, THC-P, THC-V, HHC, HHC-O HHC-P, and forms such as Wax, Dabs, Crumble, Shatter, Terpenes, or Kratom.
